# EXECUTIVE SUMMARY:

The Boulder Group is pleased to exclusively market for sale a single tenant net leased CVS Pharmacy located in North Royalton, Ohio. This CVS Pharmacy property is strategically positioned at the hard corner of a signalized intersection. CVS Pharmacy has successfully operated at this location since 1999 and has more than 5 years remaining on their primary lease term. The lease features ten 5-year renewal option periods. CVS Pharmacy is an investment grade rated company (S&P: BBB+) and publicly traded on the New York Stock Exchange using symbol "CVS".

The 9,175 square foot CVS Pharmacy is strategically positioned on the southeast corner of 130th Street and Sprague Road, a signalized intersection, in a densely populated residential area. 130th Street and Sprague Road are two primary thoroughfares in North Royalton experiencing a combined traffic count of more than 27,500 vehicles per day. Retailers located in the immediate area include Dollar General, Dairy Queen, Sunoco Gas Station and a number of local businesses. The average annual household income within a one mile radius of the property is in excess of \$79,850. There are approximately 65,300 people living within a three mile radius of the property.

The CVS Pharmacy lease has more than 5 years remaining in the primary term that expire in January 2023. The original 23 year triple net lease features ten 5-year renewal option periods. CVS Pharmacy is the nation's second-largest drugstore chain operating more than 9,700 locations in 49 states, the District of Columbia, Puerto Rico and Brazil.

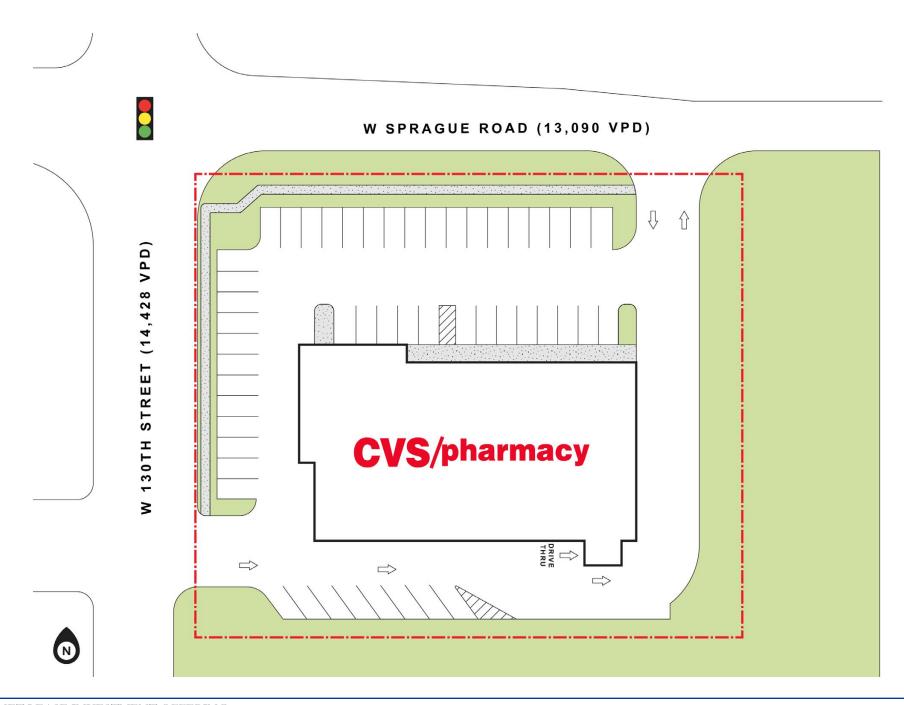




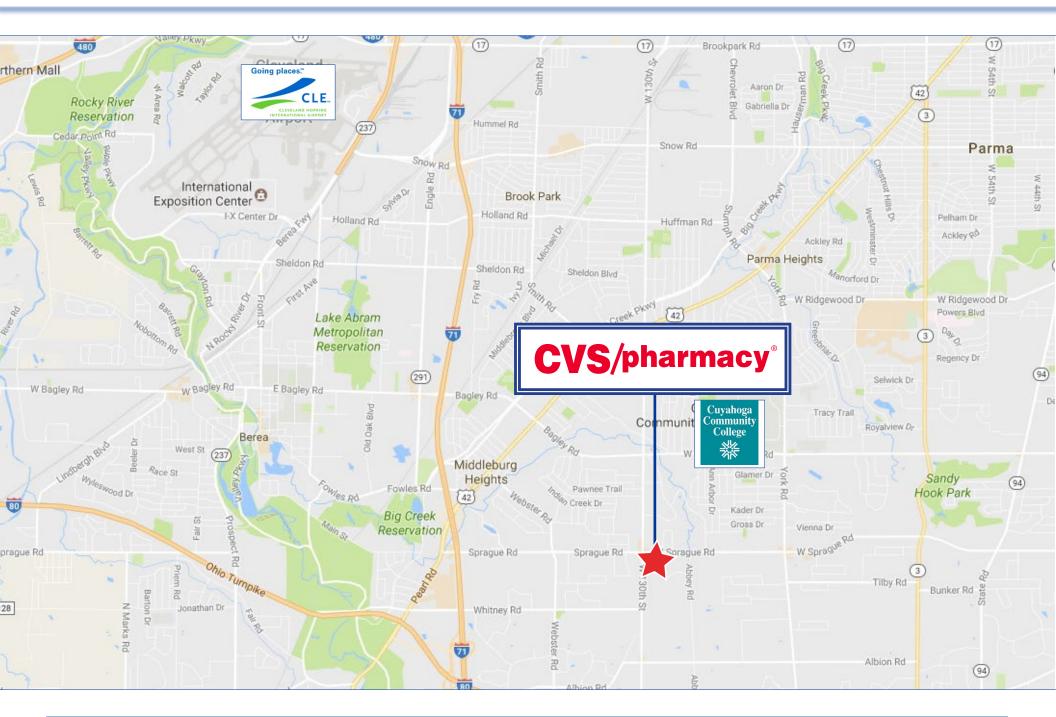

## North Royalton, Ohio

North Royalton is a city in Cuyahoga County, the second most populous county in the state of Ohio. North Royalton has a population of more than 32,500 people. Originally incorporated as a village in 1927, it achieved the status of city in 1961. North Royalton is 15 miles south of Downtown Cleveland and 25 miles north of Akron. Interstate-71 is three miles west of North Royalton and Interstate-77 is three miles east.

Cleveland Hopkins International Airport is the closest airport to North Royalton, roughly 9 miles south. North Royalton has an investment grade rating from Moody's Investors Service, one of the big three credit rating agencies, of Aa2.

### Cleveland, Ohio

Cleveland is a city in the state of Ohio and is the county seat of Cuyahoga County, the most populous county in the state. The city is located in northeastern Ohio on the southern shore of Lake Erie, approximately 60 miles west of the Pennsylvania border. Cleveland's economy has diversified sectors that include manufacturing, financial services, healthcare, and biomedical. Cleveland is home to the Rock and Roll Hall of Fame. Cleveland is part of the larger Cleveland-Akron-Canton, OH Combined Statistical Area, which has a population in excess of 3,500,000 people, and ranked as the country's 15th largest CSA.

Cleveland is home to the corporate headquarters of many large companies such as Applied Industrial Technologies, Cliffs Natural Resources, Forest City Enterprises, NACCO Industries, Sherwin-Williams Company and KeyCorp. NASA maintains a facility in Cleveland, the Glenn Research Center. Jones Day, one of the largest law firms in the U.S, began in Cleveland. Cleveland Hopkins International Airport is the city's major airport and an international airport that formerly served as a main hub for United Airlines. It holds the distinction of having the first airport-to-downtown rapid transit connection in North America, established in 1968. The Port of Cleveland, located at the Cuyahoga River's mouth, is a major bulk freight terminal on Lake Erie, receiving much of the raw materials used by the region's manufacturing industries.
